Teaser	<p>You need a license to operate a hospital pharmacy.</p> <p>You can apply for this from the local competent authority.</p>
Volltext	<p>If you want to operate a hospital pharmacy as the owner of a hospital, you must apply for a permit to do so.</p> <p>The hospital pharmacy is a functional unit of a hospital. It is responsible for the safe and proper supply of one or more hospitals with medicines and pharmacy-only medical products.</p> <p>It also informs and advises doctors, nursing staff and patients about the medicines and medical devices used.</p> <p>In order to obtain the operating license, you must provide evidence of the prescribed premises and employ a pharmacist who meets the requirements of the Pharmacy Act as a manager.</p> <p>A hospital does not necessarily need its own hospital pharmacy, but can also be supplied by the pharmacy of another hospital or a public pharmacy (hospital-supplying pharmacy) on a contractual basis.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Floor plan of the pharmacy operating rooms               <ul style="list-style-type: none"> <li>• The size, location, furnishings and function designations of the individual pharmacy operating rooms must be visible</li> <li>• For new openings: copy of the building permit from the building supervisory authority</li> </ul> </li> <li>• Proof of the rooms required for a hospital pharmacy:</li> <li>• Notification of the number of employees, broken down into specialist staff and other staff</li> </ul> <p>The following documents must be submitted by the head of the hospital pharmacy:</p> <ul style="list-style-type: none"> <li>• Identity document, proof of nationality if applicable</li> </ul>

Voraussetzungen	<ul style="list-style-type: none"> <li>• You must employ a pharmacist who fulfills the requirements of the Pharmacy Act</li> <li>• Proof of the rooms required for hospital pharmacies in accordance with the Pharmacy Operating Regulations</li> </ul>

Verfahrensablauf	<ul style="list-style-type: none"> <li>• First, you should contact your competent authority to describe your project and discuss the scope of the documents to be submitted.</li> <li>• Next, submit a complete written application.</li> <li>• Your application will be reviewed by the competent authority.</li> <li>• If necessary, the competent authority will request further documents.</li> <li>• If the requirements of the Pharmacy Act are met, you will be issued an operating license.</li> <li>• Pharmacy operations may only commence after an acceptance inspection by the competent authority.</li> </ul>

Frist	You may only start operating your hospital pharmacy once the competent authority has granted you permission to do so.

Kurztext	<ul style="list-style-type: none"> <li>• Operation of a hospital pharmacy Permit</li> <li>• A hospital pharmacy may only be operated after a permit has been issued</li> <li>• The written application must be submitted by the responsible body of the hospital</li> <li>• The head of the hospital pharmacy must be named in writing</li> <li>• A hospital does not necessarily need its own hospital pharmacy, but can also be supplied by the pharmacy of another hospital or a public pharmacy (hospital-supplying pharmacy) on a contractual basis</li> </ul>
