By participating, you can contribute to the planning process. As a public authority or other public interest body, you will be asked by the responsible authority or the body responsible for the procedure to participate and submit your comments when an impact is identified.

	You can participate as follows: Opportunity for citizens, interest groups and companies to comment or Opportunity to comment for authorities and public agencies You can submit your statements or comments on the development plan in the following ways: online, by post, orally or for the record at the competent authority or orally during a public event As a public authority or public interest body, you will be contacted by the responsible authority if you have been identified as being affected and asked to submit a statement. The comments and statements received will be collected and examined by the competent authority after the deadline. The authority then weighs up all the comments and makes a decision on them. Private and public interests are taken into account. You will be informed of the result of the assessment.
Bearbeitungsdauer	The duration of the procedure is variable and depends on the scope of the comments and statements received.
Frist	30 Tag(e) Note (for further information on the deadline): The participation period for the public is at least 30 days. For authorities and other public bodies, the participation period is at least 30 days from the request to submit a statement.
