| Volltext | <p>People with severe disabilities can receive certain benefits and compensation for disadvantages.</p> <p>For example, if you have a two-color severely disabled person's pass with certain characteristics, you can use this application to apply for a supplementary sheet and a token.</p> <p>You can then claim the following benefits:</p> <ul style="list-style-type: none"> • free transportation on local public transport or • a reduction in vehicle tax <p>To be able to use free local public transport, you must purchase a token for half a year or a whole year against payment of a personal contribution.</p> <p>You do not have to pay the personal contribution if you have certain characteristics or receive certain social benefits.</p> <p>Alternatively, you can apply for a supplement without a token instead in order to receive a reduction in vehicle</p> |
