The TI networks all those involved in the healthcare system and will enable access to the electronic patient file (ePA) in the future, for example. 	To obtain the SMC-B, you must first enter your institution in the electronic healthcare professions register (eGBR) for a fee. You then apply for the SMC-B from a trust service provider (VDA). VDAs charge an annual fee, which varies from provider to provider.
