Teaser	Would you like to run a prostitution business? You need a permit for this.
Volltext	If you want to run a prostitution business, you need a permit from the competent authority. The authority has extensive monitoring rights. It can impose legal sanctions for non-compliance with the licensing requirement.
	A prostitution business is a business in which sexual services are offered commercially by at least one other person and/or premises are provided for this purpose.
	You require a permit if you
	<ul> <li>operate a prostitution establishment, i.e. use a building, individual rooms or other fixed facilities to offer sexual services, for example as a brothel, walk-in brothel or tantra massage studio,</li> </ul>

	<ul> <li>provide a prostitution vehicle for the provision of sexual services, for example a bus, camper van, caravan or boat,</li> <li>organize or conduct a prostitution event for an open circle of participants at which sexual services are offered for payment by at least one of the persons directly present, or</li> <li>operate a prostitution agency, i.e. arrange for at least one other person to provide sexual services outside of the operator's prostitution establishments, for example a call boy or call girl agency or an escort agency. This also applies if it is only apparent from the circumstances that the procured services also include sexual acts.</li> </ul>
	The competent authority may limit the permit and impose conditions.
	The permit for the provision of a prostitution vehicle is valid for a maximum of 3 years. You can extend it on application.
	If you wish to operate your prostitution business through a proxy, you will also require a proxy permit.
	Please note that in addition to the permit requirement for the prostitution business, other permit or notification requirements apply in accordance with other regulations:
	<ul> <li>Catering trade,</li> <li>trade protection</li> <li>building protection</li> <li>water protection</li> <li>immission control</li> <li>Special use of public road areas</li> </ul>

	<ul> <li>Identity card, passport, electronic residence permit if applicable</li> <li>Operating concept</li> <li>Certificate of good conduct for submission to an authority according to document type "0", or European certificate of good conduct</li> </ul>

	Companies (legal entities), for example GmbH:
	<ul> <li>Current excerpt from the commercial register or register of cooperatives</li> <li>Copy of the articles of association</li> <li>Operating concept</li> <li>Identity card, passport, electronic residence permit for legal representation if applicable</li> <li>Certificate of good conduct for submission to an authority according to document type "0" for legal representation, or European certificate of good conduct</li> <li>Central trade register excerpt according to document type "9" for both the company and the legal representative</li> </ul>
	• Floor plan drawing
	For prostitution vehicle permit additionally:
	<ul> <li>Vehicle photo</li> <li>Operating license, registration certificate part I and part II</li> </ul>
Voraussetzungen	<ul> <li>You are at least 18 years old.</li> <li>If you wish to operate a prostitution business, you must undergo a background check by the competent authority.</li> <li>In prostitution establishments, you must ensure that the rooms used for sexual services meet certain standards. This includes the rooms are not visible from the outside the establishment has a proper emergency call system the doors can be opened from the inside at any time the rooms are not intended for use as living rooms or bedrooms.</li> <li>The places of prostitution also have adequate sanitary facilities suitable recreation and break rooms individually lockable storage facilities for personal belongings</li> <li>The prostitution vehicle meets the minimum</li> </ul>

These include a sufficiently large interior adequate interior fittings adequate sanitary facilities a valid operating license the vehicle is in a technically operational condition the doors can be opened from the inside at any time help is available at all times via technical precautions • The minimum requirements for prostitution establishments apply accordingly to the rooms used for prostitution events.
