Teaser	You can apply for an exemption from the obligation to undergo an official veterinary inspection for a livestock exhibition or livestock market.
Volltext	If you wish to organize a livestock exhibition or a livestock market, the animals must generally undergo an official veterinary inspection. Under certain conditions, however, you can apply for an exemption from this obligation.
Erforderliche Unterlagen	<p>Please provide the following information in the application and enclose the relevant supporting documents:</p> <ul style="list-style-type: none"> <li>• Completed application for exemption (with details of the event, venue and livestock)</li> <li>• Justification for the necessity of the requested exemption</li> <li>• Site plan of the event venue with marking of entrances and exits</li> <li>• Proof of existing cleaning and disinfection facilities for vehicles and persons</li> <li>• Information on the accommodation of the animals (e.g. accommodation rooms, quarantine rooms)</li> <li>• Hygiene concept for the event</li> </ul>

	<ul style="list-style-type: none"> <li>• Veterinary certificate or expert opinion, if applicable</li> <li>• If applicable, proof of exemption from the official veterinary examination (e.g. for annual or weekly markets)</li> <li>• If applicable, previous approval notices or comparable documents (for recurring events)</li> </ul>
Voraussetzungen	<p>In deviation from the legal requirements for livestock exhibitions and livestock markets, you can apply for an exemption permit if the following conditions are met:</p> <ul style="list-style-type: none"> <li>• The venue does not meet all the requirements for fencing, access routes and cleaning facilities that are normally prescribed for livestock exhibitions or livestock markets.</li> <li>• There are no concerns regarding the control of animal diseases that would speak against the event.</li> <li>• Your event is a livestock exhibition, a small-scale livestock market or a fair or weekly market that is exempt from official veterinary supervision.</li> <li>• The venue meets certain requirements, including safety precautions for access, suitable cleaning facilities and space for the animals.</li> <li>• There is no risk to animal health or animal diseases.</li> </ul>
Kosten	Fees will be charged. The amount of the fees depends on the administrative costs.
Verfahrensablauf	<ul style="list-style-type: none"> <li>• You submit the application for a special permit together with all the necessary documents to the competent authority.</li> <li>• The competent authority will check your documents. If necessary, it will request further documents or information from you.</li> <li>• The competent authority will check your application and you will receive a decision.</li> <li>• If your application is complete and meets the requirements, you will receive the exemption permit.</li> </ul>
Bearbeitungsdauer	If all the necessary documents are available, processing can take up to 6 weeks.
Frist	<ul style="list-style-type: none"> <li>• Apply for the exemption permit in good time, at least 6 weeks before the planned event.</li> <li>• You need the exemption permit to hold a livestock market or exhibition, a fair or weekly market at which live farm</li> </ul>

These farm animals belong to the livestock category: <ul style="list-style-type: none"> <li>• Horses, donkeys, mules, hinnies, zebras and zebrids</li> <li>• Cattle including bison, bison and water buffalo</li> <li>• Sheep and goats</li> <li>• pigs</li> <li>• Hares, rabbits</li> <li>• Ducks, pheasants, geese, chickens, ratites, guinea fowl, partridges, pigeons, turkeys and quails</li> <li>• Game animals</li> <li>• Camelids</li> </ul>

Kurztext	<ul style="list-style-type: none"> <li>• Livestock exhibitions and livestock markets Apply for exemption from official veterinary inspection</li> <li>• Livestock exhibitions or livestock markets usually with official veterinary inspection of the animals</li> <li>• Exemption from this obligation can be applied for</li> <li>• Requirements for the event location must be met</li> <li>• Animal disease control concerns must not conflict with this</li> <li>• Competent authority for veterinary matters</li> </ul>
