Teaser	If you are a member of a Chamber of Crafts and personal or company-related data recorded there changes, you must notify the Chamber of Crafts.
Volltext	<p>The Chamber of Skilled Crafts maintains two registers, the Handwerksrolle and the Verzeichnis über die Inhaber eines Betriebs einer zulassungsfreien Handwerks oder eines handwerksähnlichen Gewerbes, in which all skilled crafts businesses and businesses in the skilled crafts sector in the respective chamber district are recorded. In order to keep the stored data up to date, there is a notification obligation in the event of changes, which covers the following cases, among others:</p> <ul style="list-style-type: none"> <li>• Changes of address of the business owner(s) or the business premises,</li> <li>• changes in the number of permanent establishments,</li> <li>• changes in electronic contact details such as (mobile) telephone and fax numbers or e-mail addresses,</li> <li>• changes in personal details of shareholders or partners,</li> <li>• changes in persons authorized to represent companies.</li> </ul>

electronic contact data, changes, the relevant Chamber of Skilled Crafts and Small Businesses must be notified.

- Notification of changes in data must be made, among other things, if address data of sole proprietorships, partnerships or corporations as well as registered business premises change, electronic contact data (e.g. telephone number, e-mail address) changes, details of authorized representatives and shareholders change, a permanent establishment is to be deleted or an additional permanent establishment is to be registered.
- responsible: Chamber of Skilled Crafts and Small Businesses with which the business is registered.
