Teaser	If you would like to run a daycare center, you must obtain a permit from the responsible state youth welfare office.
Volltext	Facilities in which children are looked after all day or for part of the day require a permit from the relevant state youth welfare office in order to operate. The license must be applied for by the provider of the facility.
	If you would like to operate a daycare center as an independent provider, you must meet certain requirements in order to be granted the relevant permit.
	You cannot operate a daycare center without an operating permit. If you do not submit the application on time, you will not be able to open your daycare facility until a later date.
