Teaser	If you wish to care for one or more children outside the household of the legal guardian on a regular basis and for a fee, you usually need permission to do so. You can apply for this at the responsible youth welfare office.
Volltext	Children between the ages of 0 and 14 can be cared for in day care. You need a permit for day care if you want to care for a child or several children outside the household of the legal guardian during part of the day and for more than 15 hours a week for more than 3 months against payment. The permit for child day care • is granted by the local youth welfare office, • is limited to 5 years, • can be provided with additional conditions, • authorizes you to care for up to 5 foreign children
Erforderliche Unterlagen	<ul> <li>Present at the same time.</li> <li>Flawless extended police certificate of good conduct according to § 72a SGB VIII</li> <li>Measles protection</li> <li>Health certificate (renewed every 5 years)</li> <li>Proof of qualification as a child day care worker</li> </ul>
Voraussetzungen	<ul> <li>Permission will be granted if you are suitable for day care. This can be assumed if</li> <li>you distinguish yourself through your personality, professional competence and willingness to cooperate with legal guardians and other child day care providers,</li> <li>you have premises suitable for children,</li> <li>you have good knowledge of the requirements of child day care. You must have acquired this knowledge in qualified courses.</li> </ul>

Verfahrensablauf	You can apply for a care permit at the responsible youth welfare office. Submit the following documents here:
	<ul> <li>completed qualification as a child day care worker</li> <li>certificate of good conduct from the police</li> <li>medical certificate (on measles protection)</li> </ul>
	Afterwards, the premises suitable for children are checked by means of a joint inspection with the local youth welfare office.

Kurztext	<ul> <li>Permission to provide day care for children</li> <li>children aged 0-14 years can be cared for in day care facilities</li> <li>from the age of three, care in a day care center must be given priority</li> <li>a person who wants to look after a child or several children outside the household of the legal guardian during part of the day and for more than 15 hours a week for more than 3 months against payment requires permission; in accordance with the legal basis in the Eighth Book of the Social Code (SGB VIII)</li> <li>Permission is granted by the local youth welfare office</li> <li>responsible: responsible youth welfare office</li> </ul>
