Teaser	If you are an institution preserving cultural property and wish to export parts of your collection from Germany to member states of the European Union (EU) on a regular and temporary basis, you can apply for a general open license for the export of cultural property.
Volltext	You have the option of applying for a general open license for the export of cultural goods to EU member states. This is particularly recommended if you frequently  • take part in public exhibitions, • have cultural property restored or • researchers are to have the opportunity to examine the cultural property  The general open license can be granted for a maximum of 5 years.  You can apply for a general open license from the competent authority of the federal state in which your institution has its headquarters.

Voraussetzungen	<ul> <li>They are an institution that preserves cultural property.</li> <li>They guarantee that the cultural property is reintroduced undamaged and in good time.</li> </ul>

Verfahrensablauf	You can apply for a permit for the temporary export of cultural property in writing, purely online or hybrid.
	If you wish to apply for the export permit in writing:
	<ul> <li>Download the corresponding PDF form and fill it out.</li> <li>Print out the PDF form once on one side.</li> <li>The PDF contains 2 copies of the export license application.</li> <li>Both copies must be completed.</li> <li>Attach the necessary supporting documents to both copies.</li> <li>If necessary, sign and stamp the copies in the specified places.</li> <li>Send both copies and the relevant supporting documents by post to the competent authority.</li> <li>The competent authority will check your application and decide whether to issue the export license.</li> <li>If the decision is positive, the second copy will be provided with the license and sent back to you.</li> <li>Please carry this license with you when exporting the cultural object.</li> <li>If the decision on your application is negative, you will receive a written notification with a statement of reasons and information on legal remedies.</li> </ul>

- If you wish to apply for the export license online:
  - Call up the online service.
- Authenticate yourself to your BundID account as a natural person or via My Company Account as an organization.
- Complete the online form and attach the required attachments.





## Modul Sachverhalt

- Submit the online form.
- Save the confirmation of submission provided for verification purposes.
- The remaining procedural steps are the same as the written procedure.
  - An online decision is not yet possible.

If you wish to apply for the export license in hybrid form:

- Call up the online service.
- When you are asked for the identification method, click on "Without registration".
- Complete the online form.
- Submit the online form.
- Print the result PDF form once on one side in color.
- The PDF contains 2 copies of the export license application.
- Attach the missing documents to both copies.
- If necessary, sign and stamp the copies in the specified places.
- Send both copies and the corresponding supporting documents by post to the competent authority.
- The remaining procedural steps correspond to the written procedure
