	<ul> <li>When issuing certificates in the event of an insurance claim: insurance form, if applicable</li> <li>Confirmation of the theft report from the police, if applicable</li> </ul>
Voraussetzungen	<ul> <li>You have found something that does not belong to you and has a value of more than EUR 10.00.</li> <li>You are missing something and can no longer find it.</li> </ul>
Kosten	Abgabe: Es fallen keine Kosten an • none • Administrative fee in varying amounts, if applicable
Verfahrensablauf	You can report a lost or found item to the lost and found office:
	<ul> <li>You can submit the report online, in paper form or in person at the relevant lost and found office.</li> <li>You should provide as much detail as possible about the place and time as well as a description of the lost or found item.</li> <li>In any case, you should leave your contact details with the lost and found office so that you can be notified if the item is found. However, you are not obliged to do so.</li> <li>Lost property will be kept for you for at least 6 months and then disposed of.</li> </ul>
	Note: Some towns and municipalities use an online service for reporting lost property.
