Teaser	If you wish to issue plant passports as an entrepreneur, you must be authorized to do so by the competent authority. You can find out more here.
Volltext	<p>Companies wishing to issue plant passports require authorization from the competent authority.</p> <p>The plant passport is an official label for the movement of plants and plant products into EU member states. It certifies that the plants and plant products meet the requirements of the regulations on intra-Community movement and movement into protected areas. The plant passport thus certifies that the goods are free from quarantine pests and other regulated non-quarantine pests (RNQP).</p> <p>By issuing plant passports, the company also assumes obligations to monitor its crops for infestation with harmful organisms. There is also an obligation to document inspections and trade flows</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Declaration by the entrepreneur that the relevant authorization requirements have been met.</li> </ul>
Voraussetzungen	<ul style="list-style-type: none"> <li>• You have the necessary knowledge to recognize the regulated pests relevant to the company and the symptoms they cause.</li> <li>• You have an action plan in place to take the necessary measures in the event of suspected or actual occurrence of regulated pests in the company.</li> <li>• You have a prevention plan in place to minimize the risk of introducing regulated pests into the company.</li> <li>• You have a system and procedures in place to meet the traceability obligations for goods subject to plant passport requirements.</li> </ul>

Verfahrensablauf	<ul style="list-style-type: none"> <li>• As an entrepreneur, you submit the application for authorization to issue plant passports to the competent plant protection office.</li> <li>• The competent authority will check the application documents and carry out any necessary checks.</li> <li>• The authorization is issued if the check is positive.</li> </ul>

Hinweise	<p>Authorized operators have the following obligations, among others:</p> <ul style="list-style-type: none"> <li>• Before a plant passport is issued, plants, plant products and other objects must be examined by trained personnel for the possible presence of pests regulated by EU emergency measures within the meaning of Art. 30 of Regulation (EU) 2016/2031, Union quarantine pests and Union regulated non-quarantine pests (see also Art. 87, 90 of Regulation (EU) 2016/2031). The performance and results of these tests must be documented. The documentation must be kept for at least 3 years.</li> <li>• Plants and plant parts and other objects subject to plant passport requirements must be provided with a valid plant passport. The plant passport is a label and must comply in form and content with the requirements of Art. 83 of Regulation (EU) 2016/2031 and Implementing Regulation (EU) 2017/2313.</li> <li>• Authorized operators are obliged to identify and monitor critical points in the production and operational process so that there is no risk of regulated pests spreading. This must be documented and kept for at least three years.</li> </ul>
