Teaser	If you run a non-profit organisation or work for a social service, you can apply for a parking permit. This will allow you to park in certain areas for the duration of your work assignment.
Volltext	Vehicles belonging to a non-profit institution or a social service can be issued with a parking permit by the competent authority. This can, for example, entitle the holder to park free of charge in restricted stopping zones, in residents' parking zones or in parking space management zones (parking spaces with parking meters or parking ticket machines). The exemption is usually only valid for certain individual activities of the non-profit institution or social service. Please note the exact content of the exemption permit. Above all, other persons must not be endangered or hindered when using the special permit.
Erforderliche Unterlagen	The documents to be submitted vary from authority to authority. For example, you must submit a copy of the vehicle registration document.
Voraussetzungen	The competent authority shall examine the application for a parking card. There is no entitlement on the part of the applicant.
Kosten	- Exemption permit: € 10.20 to € 767.00 - The amount of the fee varies depending on the number of vehicles, the period of validity of the parking permit and its area of application.
Verfahrensablauf	You must submit an application for the granting of the exemption. How to make the application varies from
