Teaser	If you require a permit to conduct an animal exchange for the purpose of exchanging or selling animals by third parties, you must submit an application to the competent authority.
Volltext	If you wish to carry out animal exchanges for the purpose of exchanging or selling animals by third parties on a commercial basis, you require a permit to do so. An animal exchange is characterized by the fact that animals are sold or exchanged between private individuals.
Erforderliche Unterlagen	• Identity document • Certificate of good conduct • Proof of expertise, certificates • Sketch or construction drawings, plan documents of the premises or facilities
Voraussetzungen	• In order to obtain a permit, you must generally provide proof of your expertise in handling the respective animals and your reliability. In addition, the permit and the requirements are tailored to the individual case. • The rooms and facilities used for the activity must enable the animals to be fed, cared for and housed in accordance with the legal requirements.
Kosten	Depends on the fee schedule of the respective federal state.
Verfahrensablauf	If you have applied for a permit, the competent authority will make a decision promptly.
