It also provides environmental information and is important for the implementation of the EU Water Framework Directive. The register serves to provide an overview and evidence of decisions made by the authorities.</p> <p>In particular, the following are recorded in a water register</p> <ul style="list-style-type: none"> • issued permits and authorizations as well as old rights and old powers, • planning decisions and planning approvals, • water protection areas, • risk areas and designated flood plains.
