Teaser	Would you like to work as an anesthesia technician in Germany? Then you need a state permit. In order to obtain the state permit, you can have your foreign professional qualification recognized.
Volltext	The profession of anesthesia technician is regulated in Germany. This means that you need a state permit to work as an anesthesia technician assistant in Germany. With this permit, you can use the job title "anesthesia technical assistant" and work in the profession. If you have a professional qualification from the European Union (EU), the European Economic Area (EEA) or Switzerland, you can also obtain a state permit from the competent authority in Germany. In order to obtain the permit, you must have your foreign professional qualification recognized. In the recognition procedure, the competent authority compares your professional qualification with the German professional qualification and checks the

	equivalence. The equivalence of professional qualifications is an important prerequisite for obtaining a state license.
	In addition to the equivalence of the professional qualification, you must also meet other requirements for the permit to be issued. Further requirements are, for example, sufficient German language skills and health suitability.
	If your professional qualification does not originate from the EU, the EEA or Switzerland, other regulations apply. You can also apply for the procedure from abroad.
Erforderliche Unterlagen	The responsible office will tell you which documents you need to submit. Important documents are generally
	 Proof of identity (identity card or passport) Marriage certificate (if your name has changed due to marriage) Curriculum vitae Proof of your professional qualifications (e.g. certificates, professional certificate) Proof of training Proof of your relevant professional experience as an anesthesia technician or anesthesia technician assistant Proof of other relevant knowledge for working as an anesthesia technician or anesthesia technician assistant You do not yet live or work in Germany? Then you may need to provide proof: You want to work in the profession in Germany. Proof includes, for example, applications for a job, invitations to interviews or a business concept.
	You usually submit these documents later. The responsible office will inform you when you should submit the documents:

	 Proof of your personal suitability: criminal record extract or certificate of good conduct from your country of origin. The certificate must not be older than 3 months at the time of application. Proof of your health suitability: Medical certificate. The certificate must not be older than 3 months at the time of application. Proof of your German language skills: Language certificate at language level B2 according to the Common European Framework of Reference for Languages (CEFR)
	The responsible office will let you know which documents you need to submit as a simple copy, a certified copy or the original.
Voraussetzungen	 You have a professional qualification as an anesthesia technical assistant from the EU, the EEA or Switzerland. You want to work in Germany as an anesthesia technical assistant. Personal suitability: You are reliable for working as an anesthesia technician and have no criminal record. Health suitability: You are mentally and physically fit to work as an anesthesia technician. You have German language skills at the required level. This is normally language level B2 according to the Common European Framework of Reference for Languages (CEFR).
Kosten	The responsible office will inform you of the costs. The costs generally depend on the time and effort required for processing. Additional costs may also be incurred (e.g. for translations, certifications or compensatory measures). These costs vary from case to case.
Verfahrensablauf	**Application**
	You submit an application for permission to use the professional title "anaesthesia technical assistant" to the competent authority.
	You can hand in the application with the documents to

the relevant office or send it by post. Do not send any originals. Sometimes you can also send the application electronically. The responsible office will inform you.

Examination of equivalence

The competent authority will then check whether you meet all the requirements. An important requirement is the equivalence of your professional qualification. The competent body will compare your professional qualification with the German professional qualification as an anesthesia technical assistant. The professional qualification is equivalent if there are no significant differences between your foreign professional qualification and the German professional qualification.

Possible results of the examination

If your professional qualification is equivalent, your foreign professional qualification will be recognized. The competent authority can confirm the result in writing. You must still meet the other requirements. You will then receive permission to use the professional title "anaesthesia technical assistant".

Are there any significant differences between your professional qualification and the German professional qualification? You may be able to compensate for the differences through your professional experience, other knowledge or skills (lifelong learning). You must provide evidence of your professional experience. Knowledge and skills must be certified by an authority in the country in which you acquired the knowledge or skills.

However, it may be that the significant differences cannot be compensated for by this knowledge. In this case, your foreign professional qualification will not be recognized. You will then not be allowed to work as an anesthesia technician in Germany.

However, the competent authority will tell you the

	main differences and why you cannot compensate for the main differences with your professional experience. In most cases, you can take a compensatory measure. This will allow you to compensate for the main differences.
	Compensatory measures
	There are various compensatory measures:
	• Adaptation course: The adaptation course lasts a maximum of three years.
	• Aptitude test: In the aptitude test, only those areas in which significant differences have been identified are tested. The aptitude test consists of a practical examination.
	You can choose between an adaptation period or an aptitude test.
	If you successfully complete the compensation measure and meet all other requirements, you will receive permission to use the job title "anaesthesia technical assistant".
Bearbeitungsdauer	3 Monat(e) The responsible office will inform you if any documents are missing. If the documents are complete, the procedure will take a maximum of 3 months.
Frist	There is no deadline. Sometimes documents are still missing from the procedure. The responsible office will then inform you by when you must submit the documents.

Hinweise	**Freedom to provide services**
	Do you only want to offer services in Germany occasionally and for a short time? Then you usually do not need a state permit. You must fulfill these requirements:
	• You must be established in another EU or EEA member state or in Switzerland.
	• You must provide proof of your professional qualification.
	• You must not have been guilty of conduct that makes you unreliable to exercise your profession.
	• You must be in good health.
	• You must register your activity in writing with the competent authority.
	The competent authority will inform you whether you are permitted to provide services or whether you need to take an aptitude test.
	Notification of equivalence
	The equivalence assessment (recognition procedure) also takes place during the licensing procedure. You can apply for a separate decision on the result of the examination.
	Procedure for ethnic German repatriates
	As a late repatriate, you can go through the recognition

	procedure either in accordance with the laws mentioned here or in accordance with the Federal Expellee Act. You can decide for yourself. The responsible office will advise you on which procedure is right for you.
Rechtsbehelf	You can take legal action against the decision of the competent authority within a certain period of time (e.g. lodge an objection). The decision will then be reviewed. Details can be found in the information on legal remedies at the end of your decision. We recommend that you first speak to the responsible office before taking legal action against the decision.
Kurztext	 Apply for recognition as an anaesthesia technical assistant with a professional qualification from the EU/EEA/Switzerland. To work as an anesthesia technical assistant in Germany, you need a state permit. With this permit, you can officially call yourself an "anesthesia technical assistant" and work in the profession. Professional qualifications from the European Union (EU), the European Economic Area (EEA) or Switzerland can also be used to obtain a state permit in Germany.
