Volltext	You must give notification using the Minimum Wage Notification Portal if your employee works in one of the following industries: • Construction • Hotels and catering • Passenger transport • Freight, transportation and related logistics • Fairgrounds • Forestry • Cleaning of buildings • Companies involved in setting up and dismantling trade fairs and exhibitions • Meat and meat-processing • Prostitution

You must enter the following information:

- Employees name and date of birth
- Start date and length of employment or assignment
