| Volltext                 | The purchase and sale of certain luxury foods are<br>generally subject to tax. This also includes coffee. You<br>therefore need a permit to handle untaxed coffee.<br>The permit authorizes you to<br>• store untaxed coffee or<br>• produce goods with it.   |

• You can call up the decision (approval or rejection) for the submitted form digitally in the customs portal.

• Complete the respective form in full and attach any additional documents. Each form contains instructions for completion and, if necessary, further information on the procedure applied for.

• You send everything by post to your local main customs office. The main customs office will check your application.

• You will receive a decision by postin the form of apermit or arefusal.

#### Bearbeitungsdauer

The processing time is usually 1 to 3 weeks. It depends on the specific circumstances of each individual case, in particular on the result of the examination of the
