Teaser	The Künstlersozialkasse will advise you on all questions concerning the Künstlersozialabgabe.
Volltext	<p>The Künstlersozialkasse (KSK) informs you, as a potential entrepreneur or exploiter who is liable to pay the artists' social security contribution, about your rights and obligations.</p> <p>You will receive information on whether you as an entrepreneur or exploiter are subject to the artists' social security contribution and what the amount of the contribution is.</p> <p>This includes the following points:</p> <ul style="list-style-type: none"> • why are you obligated to pay the artists' social security contribution, • when do you have to pay the artists' social security contribution, • what is to be included in your remuneration report, • who is a self-employed artist or journalist, • what is the rate of the levy, • what is the general procedure, • how do you fulfill your obligation to keep records, • what information do you have to provide, • when do you have to pay a late payment penalty, • what is the statute of limitations, • what is a compensation association.

It is a special feature that self-employed artistic or journalistic persons only have to pay half of their contributions themselves. The other half is financed by a federal subsidy and the companies' artists' social
