To do this, you should make sure that your prescription includes the right information. The also applies if you want to buy medicine from a pharmacy in your own country with a prescription from a doctor abroad. You should also be aware of rules on pharmacy expenses and how to get a reimbursement.</p> <p>Medicine that doesn't require a prescription can be bought freely throughout the EU and is not covered here.
