As a Cabin Crew Training Organization (CCTO), you can apply for the following in the area of training and review programs for cabin crews:

- Introduction or changes to the training program Basic training

You require further approvals if you

- want to have synthetic flight training devices, such as simulators or FSTDs, recognized.
- introduce or expand alternative training and qualification programs for flight crews (ATQP).
- want to issue flight attendant certificates. You will receive approval for the issue of cabin crew attestations if you apply for them as part of the introduction or modification of cabin crew training and checking programs, the Federal Aviation Office has already approved the basic training for cabin crew and you apply for them independently of training and checking programs. You can reorder additional forms for cabin crew attestations.

Voraussetzungen

- Your company is based in Germany.
- The application for flight crews can only be submitted by CAT operators. in the area of cabin crew and flight attendant certificates is only possible through CAT operators or a cabin crew organization (CCTO). in the area of Alternative Training and Qualification Program (ATQP) is only possible through CAT operators.
- As a CAT operator, you must present or apply for an AOC (Air Operator Certificate).

Kosten

Gebühr: 100€ - 2.000€
 The Aviation Administration Cost Ordinance (LuftkostV) provides information on the exact amounts. You will receive a notification with a QR code for payment.

Verfahrensablauf

You can apply for a permit online, by e-mail, by post or by fax.

Online application:

- Go to the federal portal and open the online application. This will guide you step by step through the required information and necessary documents.
- Upload the required documents as a file or make them available as a download link and submit the application.
- If anything is unclear or information is missing, the Luftfahrt-Bundesamt will contact you.
- The Luftfahrt-Bundesamt will check whether the requirements have been met and will send you a decision, a notification of costs, a certificate of approval for the initial approval, a new approval certificate in the event of changes.
- You pay the fees.
