Teaser	If you produce or sell beef, you can receive aid for private storage during EU market organization measures. To do so, apply to the Federal Office for Agriculture and Food (BLE) for a private storage contract.
Volltext	<p>The European Union (EU) can support agricultural market prices by granting private storage aid for beef. This can support you as a market participant in crises in the beef sector.</p> <p>Only when the EU Commission publishes a corresponding market regulation measure can you, as a trader or producer of beef, apply to the Federal Office for Agriculture and Food (BLE) to conclude a storage contract for private storage. Storage over contractually agreed periods relieves the markets and stabilizes prices.</p>
