Volltext	<p>The European Union (EU) can support agricultural market prices by granting private storage aid for beef. This supports you as a market participant in crises in the beef sector.</p> <p>Once you have concluded a contract with the Federal Office for Agriculture and Food (BLE) for private storage and the contractual storage period ends, you can apply for the aid from the BLE.</p> <p>Detailed information on the general conditions can be found in the relevant announcement.</p>

Alternatively, you can print out the completed online application and send it to the BLE by post with the required documents.</li> <li>• The BLE will check your application and contact you if anything is unclear or information is missing.</li> <li>• The BLE will send you a decision on the granting of aid or a rejection.</li> </ul> <p>Apply for aid by e-mail or post:</p> <ul style="list-style-type: none"> <li>• Download the application form from the BLE website. Note: Forms are only available on the BLE website if there is an EU announcement.</li> <li>• Complete the application form.</li> <li>• Send the completed and signed application form with any required documents to the BLE by e-mail or post.</li> <li>• The BLE will check your application and contact you if anything is unclear or if any information is missing. - Prerequisites: A contract for private storage was previously concluded with the Federal Office for Agriculture and Food (BLE) and the storage period stipulated in the storage contract has expired
- Required documents: Application The announcement provides information on any other documents required
- Costs: none
- Deadlines: to be taken from the announcement
- Application online, by e-mail or by post to the BLE
- Processing time: to be taken from the announcement
- Responsible: Federal Office for Agriculture and Food (BLE)
