This supports you as a market participant in crises in the beef sector.</p> <p>Once you have concluded a contract with the Federal Office for Agriculture and Food (BLE) for private storage and the contractual storage period ends, you can apply for the aid from the BLE.</p> <p>Detailed information on the general conditions can be found in the relevant announcement.</p>

Apply for aid online:

- Call up the online application. The online application will be activated as soon as the announcement is published.
- The online application will guide you step by step through the necessary information.
- Upload any required documents and submit the application online. Alternatively, you can print out the completed online application and send it to the BLE by post with the required documents.
- The BLE will check your application and contact you if anything is unclear or information is missing.
- The BLE will send you
 - a decision on the granting of aid or
 - a rejection.

Apply for aid by e-mail or post:

- Download the application form from the BLE website. Note: Forms are only available on the BLE website if there is an EU announcement.
- Complete the application form.
- Send the completed and signed application form with any required documents to the BLE by e-mail or post.
- The BLE will check your application and contact you if anything is unclear or if any information is missing. The BLE will send you
 - a decision on the granting of aid or
 - a rejection.
