| Teaser                           | As an employer, you must register your employees<br>who are subject to social insurance contributions. You<br>will need a company number for this.  |
| Volltext                         | As soon as you employ the first person subject to<br>compulsory insurance, you must apply for a company<br>number for the company in which the person works.<br>The company number is usually issued by the Federal<br>Employment Agency upon electronic application. A<br>customer data record is created for you in which your<br>company master data is registered. The social<br>insurance institutions can then use the company<br>number to assign the notifications to the health,<br>pension and unemployment insurance schemes to<br>your employment company.<br>One or more company numbers?<br>• As the employer of a company with only one location,<br>you only need one company numbers.<br>• You will need several company numbers if you have<br>branches in several municipalities.<br>• You also need several establishment numbers if you<br>are the owner of several establishments in the same<br>municipality, each of which forms an independent<br>economic unit.<br>Registered office abroad |

|                          | <ul> <li>the name used by the employing company in legal transactions, including any additions to the legal form,</li> <li>unregistered civil law partnership: first and last names of the partners,</li> <li>sole proprietorship not entered in the commercial register: First name and surname of the employer,</li> <li>private household: first name and surname of the head of household,</li> <li>the employment address, i.e. the current address of the company at which the employees actually work,</li> <li>if necessary, a different address to be used for postal delivery,</li> <li>additional communication channels such as telephone number, fax or e-mail address,</li> <li>the economic focus of the employing company,</li> <li>the accident insurance company number for the company to which the employing company belongs,</li> <li>Contact person (name, function, telephone number) for queries regarding the notification procedure; this can also be the contact details of a contracted service provider, e.g. a tax consultancy,</li> </ul> |

|                   | <ul> <li>Go to the online application on the Federal<br/>Employment Agency website.</li> <li>Answer the initial questions in the selection fields and<br/>follow the online form through the rest of the<br/>application process.</li> <li>In most cases, the company number is assigned and<br/>displayed immediately.</li> <li>In addition, the employer will receive a postal<br/>confirmation of the company number and the saved<br/>master data.</li> </ul> |
|                   | Note: If there are changes to the master data or the<br>business closes, you must notify the Federal<br>Employment Agency electronically without delay. As a<br>rule, your payroll accounting software automatically<br>triggers a corresponding notification to the Federal<br>Employment Agency as soon as you enter the relevant<br>changes in the master data.  |
