Volltext	Surveyors take on certain tasks in mining that arise from the Federal Mining Act and the Markscheider Mining Ordinance, such as surveying in mining, assessing safety-relevant geological and geotechnical conditions and can certify facts of public faith with the so-called cracks they produce. Insofar as the so-called "other documents" are sufficient for surface operations instead of cracks, consisting of the components of the pit pattern and other documents, these can be prepared and added by "other persons" (as mine surveyors). These "other persons" require the recognition of the competent authority for individual establishments. A pit pattern is only not required if the mining contractor has received an exemption from the pit profile requirement from the competent mining authority.
