Through joint operations, the cooperative can also promote the social or cultural interests of its members.</p> <p>A cooperative must be entered in the register of cooperatives. The registration must be made by all members of the board. Registration by an authorised representative is excluded.</p> <p>After successful registration, you will receive a registration notification.</p> <p>Hint: The cooperative entered in the register of cooperatives is a legal entity with legal capacity and, due to the form of company chosen, is automatically a</p>

<b>Kosten</b>	The amount of the fee for registration is determined by the Act on Costs of Voluntary Jurisdiction for Courts and Notaries (GNotKG) in conjunction with the Ordinance on Fees in Commercial, Partnership and Cooperative Register Matters. In addition, expenses are incurred for the public announcement of the registration.
