| Volltext                         | Insured persons in the statutory health insurance are entitled to the supply of pharmacy-only medicines and to the supply with bandages. The costs are covered by the health insurance companies.          |
|                                  | Exception: For insured persons over the age of 18, the costs for so-called minor funds are not covered. These include:   |
|                                  | <ul> <li>Medicines for use in colds and flu-like infections</li> <li>oral and pharyngeal therapeutics (except for fungal infections),</li> <li>Laxative</li> <li>Medicines for motion sickness.</li> </ul> |
|                                  | The costs for funds that you can buy without prescription are generally not covered. Exception:  • Medicinal products that are standard therapy for serious illnesses and are prescribed by the doctor.    |
|                                  | The choice of prescribed remedies may be limited by discount agreements between health insurance   |
