Volltext	<p>Persons with statutory health insurance are entitled to medical treatment if necessary. Medical treatment should be appropriate and necessary. It may:</p> <ul style="list-style-type: none"> <li>• the prevention of diseases</li> </ul> <p>or</p> <ul style="list-style-type: none"> <li>• the early detection and treatment of diseases</li> </ul> <p>serve.</p> <p>Medical treatment also includes the assistance of other persons if this is prescribed by a doctor.</p> <p>Legally insured persons can visit any doctor who is licensed to provide contract medical care. These can be, for example, family doctors or specialists in medical care centres, practices or outpatient facilities. In most cases, it makes sense to contact the family doctor first.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• You must be a member of a statutory health insurance company.</li> <li>• A medical prescription is required for the use of services initiated by a panel doctor, which may have to be approved by the health insurance fund before the use of services.</li> <li>• Health insurance card or treatment certificate</li> </ul>

Kosten	As a rule, there are no costs for medical treatment. Your health insurance company will inform you about the statutory co-payments for therapies or medication
