| Volltext                      | <p>Anyone who, as a commercial road haulage company with Community licences, uses drivers who do not belong to a member state of the European Union (EU) or a state party to the Agreement on the European Economic Area or Switzerland requires a driver attestation for the persons concerned. This is applied for by the company for the driving personnel.</p> <p>The regulation serves as proof that there is no illegal or abusive employment of workers from non-EU countries.</p> <p>The driver attestation entitles the driver to drive the vehicle on behalf of the road haulage undertaking within the EU. It is granted for a period of up to 5 years. However, it can also be limited to a shorter period of time if the residence permit or passport expires earlier. If the employment relationship is terminated, the driver attestation must be returned to the licensing authority.</p> <p>The driver must carry the original driver attestation with him every time he travels.
