Volltext	<p>The residence permit for continuing a course of study started in another EU country is a temporary residence permit. The residence permit is extended for the duration of the compulsory period of study or exchange programme carried out in Germany.</p> <p>The same conditions apply to the renewal of your residence permit as to the issuance. In particular, your livelihood should be secured for the duration of your studies in Germany.</p> <p>As a rule, the residence permit cannot be extended if this was already excluded when the residence permit was issued or last extended.</p>

Find out whether your immigration authority offers the electronic application for a residence permit. • If the application is only possible in person, please arrange an appointment with the Foreigners' Registration Office. • During the appointment, your application will be received and your supporting documents will be checked (please bring them with you to the appointment). issuance of the electronic residence permit (eAT).

- In the event of an electronic application, the Foreigners' Registration Office will contact you after receipt of your online application in order to arrange an appointment at the Foreigners' Registration Office. During the appointment, your proof will be checked (please bring it with you to the appointment) and your fingerprints will be taken for the issuance of the eAT card.

- If your application is granted, the Foreigners' Registration Office will arrange for the eAT card to be produced.

- After about six to eight weeks, you can pick up the eAT card at the Foreigners' Registration Office.

- Fees apply for the extension of the residence permit. The timing and form of payment vary depending on the authority

Extension to continue studies started in another EU country
- Residence permit for the continuation of studies started in another EU country is extended if its validity expires in the near future and the compulsory period of study in Germany is to be continued beyond its period of validity.
- The extension must be applied for no later than eight weeks before the expiry of the time limit.
- An extension of the residence permit to continue a course of study started in another EU country is only possible if the conditions that were met when it was first issued are still met.
- When extended, the residence permit is again
