| Teaser | <p>If you want to work as a researcher at a German research institution and already have a residence permit from another EU member state for the purpose of research, you can obtain a residence permit under certain conditions.</p> |
| Volltext | <p>You can obtain a residence permit for the purpose of research if you hold a residence permit from another EU Member State valid for the duration of the procedure for the purpose of research.</p> <p>The residence permit for the purpose of research for mobile researchers is a temporary residence permit. It shall be granted for the duration of the research project, but for a maximum of one year.</p> <p>The residence permit entitles the holder to take up research activities at the research institution specified in the hosting agreement and to take up teaching activities. Changes to the research project during the stay do not lead to the loss of this entitlement.</p> <p>If the application for the issuance of the residence permit is submitted at least 30 days before the start of the stay in the Federal territory and the residence permit of the other Member State is still valid, residence and employment in the Federal territory are deemed to be permitted for up to 180 days within a</p> |

- If the application is only possible in person, make an appointment with the Foreigners' Registration Office. During the appointment, your application will be received and your supporting documents will be checked (bring them with you to the appointment). Your fingerprints will be taken to produce an electronic residence permit (eAT card).
- In the event of an electronic application, the Foreigners' Registration Office will contact you upon receipt of your online application in order to make an appointment at the Foreigners' Registration Office if necessary. During the appointment, your documents will be checked (bring them with you to the appointment) and your fingerprints will be taken for the production of the electronic residence title (eAT card).
- If your application is granted, the Foreigners' Registration Office will arrange for the eAT card to be produced.
- After about six to eight weeks, you can pick up the eAT card at the Foreigners' Registration Office.
- The eAT card must always be picked up in person.

Fees apply for the issuance of the residence permit. The timing and form of payment vary depending on the authority.

The application can also be submitted to the Federal Office for Migration and Refugees, which will forward your application to the responsible immigration authority.

Frist

- Application for a residence permit for the purpose of research for mobile researchers at least eight weeks before the expiry of your valid residence permit. If you are already a researcher in Germany as part of short-term mobility, the application must be submitted no later than 30 days before the end of your permitted stay in Germany.

- Residence permit for the purpose of gainful employment Grant for mobile researchers
 - Foreigners who hold a valid residence permit from another EU member state in accordance with Directive (EU) 2016/801 for the purpose of research and who wish to work at a German research institution for more than 180 years but not more than one year can obtain the residence permit for mobile researchers.
 - The residence permit entitles the holder to take up research activities at the research institution specified in the hosting agreement and to take up teaching activities.
 - The residence permit for mobile researchers is a temporary residence permit. It shall be granted for the duration of the research project, but for a maximum of one year.
 - If the application for the issue of a residence permit is submitted at least 30 days before the start of the stay in the Federal territory and the residence permit of the other Member State is still valid, residence and employment in the Federal territory are deemed to be permitted for up to 180 days within a period of 360 days from entry before a decision is taken on the application.
 - Spouses of mobile researchers holders are also entitled to a residence permit.
 - Depending on the immigration authority and concerns, the application is possible via the Internet or in person.
 - There is a fee for the issuance of the residence permit. The timing and form of payment vary depending on the authority.
 - Responsible: the immigration authority responsible for the applicant's place of residence;
The application can also be submitted to the Federal Office for Migration and Refugees, which acts as the National Contact Point for the implementation of Directive (EU) 2016/801.
