Teaser	You can extend your residence permit for spouse reunification with foreigners if you meet certain requirements.
Volltext	The residence permit for spouse reunification with foreigners is a temporary residence permit. You can apply for an extension of your residence permit if you wish to stay in Germany and your spouse or partner is in possession of a valid residence permit in Germany.
	In principle, the same conditions apply to the extension of the residence permit as to the grant.
	In the event of an extension, your residence permit will be limited again. The residence permit is extended for the period of validity of the spouse's or partner's residence permit.
	As a rule, the residence permit cannot be extended if this was already excluded when the residence permit was issued or last extended.
	If you were obliged to attend an integration course when you first issued your residence permit, this will be taken into account when your residence permit is extended. If you have not yet taken part in an integration course, the Foreigners' Registration Office may reject your application for an extension of your

	residence permit. If you have not yet completed the integration course, the residence permit will only be extended by one year until you successfully complete it or provide proof that your integration into social life has taken place elsewhere.

Voraussetzungen	<ul> <li>You have a recognised and valid passport or passport substitute as well as a valid residence permit for family reunification in accordance with §§ 29 and 30 of the Residence Act.</li> <li>The validity period of your residence permit will expire in the near future.</li> <li>Your spouse or partner is in possession of a valid residence permit.</li> <li>There is no interest in expulsion against you.</li> <li>Your stay does not endanger or adversely affect the interests of the Federal Republic of Germany</li> <li>Their livelihood is secured.</li> <li>There is sufficient living space for the whole family.</li> </ul>
Kosten	• Extension of the residence permit for the implementation of a qualification measure for the recognition of foreign professional qualifications:
	for a further stay of up to three months: EUR 96
	for a further stay of more than three months: EUR 93
	<ul> <li>Under certain conditions, a fee reduction or exemption may be considered.</li> </ul>
Verfahrensablauf	The extension of your residence permit must be applied for at the immigration authority responsible for your place of residence.

	<ul> <li>Depending on the immigration authority and concerns, it may be possible to apply via the Internet. Find out whether your immigration authority offers the electronic application for a residence permit.</li> <li>If the application is only possible in person, please arrange an appointment with the Foreigners' Registration Office.</li> <li>During the appointment, your application will be received and your supporting documents will be checked (please bring them with you to the appointment). Your fingerprints will be taken for the issuance of the electronic residence permit (eAT).</li> <li>In the event of an electronic application, the Foreigners' Registration Office will contact you upon receipt of your online application to arrange an appointment, your certificates will be checked (please bring them with you to the appointment) and your fingerprints will be taken for the issuance of the eAT.</li> <li>If your application is granted, the Foreigners' Registration Office will arrange for the eAT.</li> <li>After about six to eight weeks, you can pick up the eAT at the Foreigners' Registration Office.</li> </ul>
	Fees apply for the extension of the residence permit. The timing and form of payment vary depending on the authority

	<ul> <li>subsequent immigration of the spouse to foreigners <ul> <li>Residence permit for the person joining the country can be extended if its validity expires in the near future and the marital cohabitation/civil partnership continues.</li> <li>The residence permit for the person joining the family is extended for the period of validity of the family member's residence permit in Germany.</li> <li>In principle, the same conditions apply to the extension of the residence permit as to the grant.</li> <li>The extension must be applied for no later than eight weeks before the expiry of the time limit.</li> <li>The extension is excluded if the extension has already been excluded by the Foreigners' Registration Office when it was granted or the last extension.</li> <li>Insofar as the obligation to attend an integration course was pronounced when the residence permit was issued, it must be proven that the obligation has been completed, the Foreigners' Registration Office may refuse the extension or extend the residence permit only for one year until the course has been successfully completed or proof has been provided that the integration into social life has taken place elsewhere.</li> <li>Depending on the immigration authority and concerns, the application is possible via the Internet or only in person.</li> <li>Renewal fees apply.
