Kosten	The fee is based on the scale of charges for road transport measures (GebOSt)
Verfahrensablauf	You must submit an application to the driving licence authority responsible for you (usually that of your place of residence).
Bearbeitungsdauer	The processing time depends on the workload of the respective driving licence authority.
Frist	Please remember to apply for your driver's license well in advance of expiration.
