Teaser	If the other parent does not provide maintenance, you can receive support from the conservatorship and seek advice on how to proceed.
Volltext	Parents are obliged to provide maintenance for their children. If a parent does not live with his child in a household, he is obliged to pay maintenance through monetary payments. However, this parent does not always do this. There can be various reasons for this. For those affected, the question arises as to how they can proceed here. A child has a legal right to maintenance. The Youth Welfare Office, in the form of conservatorship, can advise children and their affected parents and support them in asserting their claim. For example, the conservatorship can help to determine the amount of maintenance payments and possibly also create a title with which the maintenance can be foreclosed. However, the means to be initiated are always individual and can be discussed in a personal conversation.

	• Birth certificate of the child • Furthermore, all documents that may already exist (such as letter from a lawyer, maintenance order, etc.) are helpful.
Voraussetzungen	• Children up to the age of 21 receive counselling.
Kosten	There are no costs.
Verfahrensablauf	Advice, support, conservatorship: • The conservatorship can be set up in person or applied for by means of a written application. • A personal interview makes sense. For this purpose, an appointment is arranged, which usually lasts 30 to 60 minutes.
Bearbeitungsdauer	After a personal consultation (about 30 to 60 minutes), the processing usually takes place immediately. The duration may vary in individual cases.
Frist	A child (and the parent with whom he lives) receives advice and support from the conservatorship until the age of 21.
