Teaser	You can apply for an exemption from the permit requirement for the acquisition and possession of weapons.
Volltext	Basically, you need a permit to acquire and possess weapons. Deviating from this, there are specifically named exceptional cases. In addition, you have the option of applying for an exception in individual cases, provided that there are special reasons and there are no objections to public security and order. However, this is only possible for cases that are comparable to the specifically named exceptional cases.
