The TI networks all those involved in the healthcare system and will enable access to the electronic patient file (ePA) in the future, for example. There are different SMC-Bs for different professional groups. There is an SMC-B for

	To obtain the SMC-B, you must first enter your institution in the electronic healthcare professions register (eGBR) for a fee. You then apply for the SMC-B from a trust service provider (VDA). VDAs charge an annual fee, which varies from provider to provider.
Erforderliche Unterlagen	 Completed application Scan or photo of proof of your institution (e.g. power of attorney, articles of association) IK (institution identification code) number eHBA (electronic health professional card) number of a person belonging to the company
Voraussetzungen	 They must be authorized to provide services. They must be authorized to represent the institution externally. The employee must have an eHBA. You must pay the administration fee.
Kosten	Verwaltungsgebühr: 40€ There is a fixed administration fee of EUR 40.00. The selected VDA also charges its own costs for the provision of the SMC-B.
Verfahrensablauf	 You can apply for the SMC-B online as a nursing, obstetrics or physiotherapy facility: Go to the specialist portal of the electronic healthcare professions register (eGBR) and complete the online application Once your application has been received, it will be checked. The review costs an administrative fee. Once the check has been completed, you will receive an email with the result of the check and your process number. You can use the transaction number to order an SMCB from a trust service provider (VDA) of your choice for a fee. The VDAs charge an annual fee, which varies from provider to provider
