It enables people working in the healthcare professions in an institution to access the telematics infrastructure (TI). The TI networks all those involved in the healthcare system and will enable access to the electronic patient file (ePA) in the future, for example.</p> <p>There are different SMC-Bs for different professional groups. You then apply for the SMC-B from a trust service provider (VDA). VDAs charge an annual fee, which varies from provider to provider.</p>

Verfahrensablauf	<p>You can apply for the SMC-B online as a nursing, obstetrics or physiotherapy facility:</p> <ul style="list-style-type: none"> • Go to the specialist portal of the electronic healthcare professions register (eGBR) and complete the online application • Once your application has been received, it will be checked. • The review costs an administrative fee. • Once the check has been completed, you will receive an email with the result of the check and your process number. • You can use the transaction number to order an SMCB from a trust service provider (VDA) of your choice for a fee. • The VDAs charge an annual fee, which varies from provider to provider
