Teaser	If you have an A 1 or A 2 motorcycle license, you can upgrade to the next higher category under certain conditions.
Volltext	<p>If you have held a category A1 or A 2 driving license for at least 2 years, passing the practical test is sufficient to upgrade to A2 or A (promotion). A theory test is not necessary.</p> <p>The category A1 driving license entitles you to drive motorcycles (also with sidecars) with an engine capacity of up to 125 cm³, an engine power of no more than 11 kW, where the ratio of power to weight does not exceed 0.1 kW/kg and three-wheeled motor vehicles with symmetrically arranged wheels and an engine capacity of more than 50 cm³ for combustion engines or a maximum design speed of more than 45 km/h and with a power of up to 15 kW.</p> <p>The category A 2 driving license entitles you to drive motorcycles (also with sidecars) with a maximum engine power of 35 kW and a power/weight ratio of no more than 0.2 kW/kg, which are not derived from a motorcycle with an engine power of more than 70 kW. Class A 2 includes classes A1 and AM.</p> <p>The category A driving license entitles you to drive motorcycles (also with sidecars) with an engine capacity of more than 50 cm³ or with a maximum</p>

speed of more than 45 km/h determined by the type of construction and three-wheeled motor vehicles with a power output of more than 15 kW and three-wheeled motor vehicles with symmetrically arranged wheels and an engine capacity of more than 50 cm³ with internal combustion engines or a maximum speed of more than 45 km/h determined by the type of construction and with a power output of more than 15 kW.

Erforderliche Unterlagen

- Valid identity card or passport (if necessary with current registration certificate)
- Application for a driver's license
- a biometric photograph in accordance with the provisions of the Passport Ordinance (size 45x35 mm)
- Eye test certificate in accordance with Annex 6 No. 1.1 FeV (not older than two years)
- Proof of participation in a first aid training course
- Current driver's license

Voraussetzungen

- You must be the holder of an A1 or A2 driving license
- You must have your main residence in the Federal Republic of Germany
- The minimum age for category A2 is 18 years.
- The minimum age for category A is 24 years; if you previously held an A 2, the minimum age is 20 years.
- You have been in possession of a category A1 or A 2 driving license for 2 years

Kosten

The fee is based on the scale of fees for road traffic measures (GebOSt).

Verfahrensablauf

You must apply to your local driving license authority for an extension of your driving license from A1 or A2 to A2 or A.

The driving license is usually issued by the driving examiner once you have passed the driving test. The previous driver's license must be handed in in exchange.

Bearbeitungsdauer

The processing time may vary depending on how busy your local driving license authority is.

There is no deadline.

Kurztext	<ul style="list-style-type: none"> • Driving license extension to the next higher category with existing category A1 or A2 (upgrade) • If the applicant wishes to upgrade their category A1 driving license to category A 2 or upgrade category A2 to category A, they only need to take a practical test if they have held the A1 or A 2 driving license for at least 2 years (so-called upgrade). A theory test is not necessary. • The relevant competent driving license authority is responsible (usually the one in your place of residence)
