Teaser	You can extend your driving license with a class B driving license.
Volltext	You can extend your existing driving license to a category B license. The category B driving license is issued for an unlimited period. With a category B driving license, you can drive motor vehicles with a maximum permissible mass of 3.5 t and designed for no more than eight people. You can transport trailers weighing less than 750 kg with a category B license. If the total mass of the vehicle combination is a maximum of 3.5 t, the trailer may also weigh more than 750 kg.
Erforderliche Unterlagen	• valid identity card or passport (with current registration certificate if applicable) • a biometric photograph in accordance with the provisions of the Passport Ordinance (size 45 x35, portrait format, frontal view) • Eye test certificate in accordance with Annex 6 No. 1.1 FeV (not older than two years) • Proof of first aid training (if not already presented to the driving license authority)

	• Current driving license • Details of driving school
Voraussetzungen	• You must be in possession of a driver's license category • You must have your main residence in the Federal Republic of Germany • The minimum age is 18 years. You can apply for an extension of your driving license at the earliest 6 months before reaching the minimum age.
Kosten	The fee is based on the applicable scale of fees for road traffic measures (GebOSt).
Verfahrensablauf	You must apply to your competent driving license authority for an extension of your driving license to category B.
Bearbeitungsdauer	• depending on the workload of the responsible driving license authority
Frist	The practical examination must be taken within twelve months of passing the theoretical examination. Otherwise the theoretical examination loses its validity.

Kurztext	• Driving license extension to category B • the applicant can extend his/her existing driving license to include category B • Permitted vehicles: motor vehicles (with the exception of motorcycles) • up to 3500 kg gross vehicle weight (GVW), • with up to 8 seats (in addition to the driver's seat) • also with a trailer (maximum permissible mass of the trailer: 750 kg) • also with a heavier trailer, provided the combination

	does not exceed 3500 kg • The competent driving license authority is responsible in each case (usually that of the place of residence)
