Teaser	Would you like to continue your bus and coach company? You can apply for the necessary permit from the licensing authority responsible for you.
Volltext	You require a permit for the commercial transportation of passengers by bus or coach. Before the temporary permit expires, you can submit a corresponding application for reissue to the competent licensing authority. This can then lead to a seamless transition of the approved bus and coach operation on the basis of a new, again temporary permit.

## Sachverhalt

pursuant to Section 2 (2) No. 2/ Section 2 (3) of the Professional Access Ordinance for Road Passenger Transport -PBZugV), not older than 3 months

- Clearance certificate from the tax office, the municipality, the social insurance institution and the employers' liability insurance association, not older than 3 months (from the company, the legal representative and the person appointed to manage the business / transport management)
- Certificate of good conduct for submission to the authorities in accordance with Section 30 (5) BZRG
- Extract from the central trade register in accordance with Section 150 (5) GewO (for companies)
- Extract from the driving aptitude register (FAER)

General documents:

- Vehicle list
- Proof of liability insurance for buses and coaches including risk identification number (WKZ)
- Business registration

## Voraussetzungen

- The applicant is or was already in possession of a bus and coach permit as an entrepreneur.
  - The safety and efficiency of the operation is guaranteed.
  - There are no facts indicating the unreliability of the applicant as an entrepreneur or of the person appointed to manage the business.
  - The applicant as entrepreneur or the person appointed to manage the business is professionally qualified.
  - The applicant and the entrepreneurs appointed by the applicant to provide transport services have their registered office or place of business within the meaning of commercial law in Germany.
  - The reissue of the permit is limited to a period of up to 10 years.

Legal entities under public law are deemed to have fulfilled the requirements.

Verfahrensablauf	<p>Proceed as follows to obtain a reissue of the permit for the commercial transportation of passengers by bus or coach:</p> <ul style="list-style-type: none"> <li>• Submit a corresponding application to the licensing authority responsible for you and enclose all the necessary documents with the application.</li> <li>• The authority will process your application and carry out the necessary hearing procedures.</li> <li>• You will receive notification of the decision to reissue the bus and coach permit.</li> <li>• If applicable, you will receive the certificate of approval.</li> </ul>
Bearbeitungsdauer	<p>The processing time may vary between the responsible approval authorities. The processing time may depend, among other things, on whether all documents relevant to the decision have been submitted or whether additional requests for documents are necessary. become necessary.</p>
Frist	<p>Deadlines only start to run when an application is ready for a decision. If your application is complete, a decision will be made within 3 months. The deadline can be extended by 3 months if necessary. if necessary.</p>
