Volltext	You require a permit to transfer the authorization for the commercial transport of passengers by bus or coach. You can submit a corresponding application to the licensing authority responsible for you.

permit is to be transferred

- Certificates of employment or examination certificates (for professional suitability) of the applicant or the person appointed to manage the business
- Equity certificate / additional certificate (form in accordance with § 2 Para. 2 No. 2/ § 2 Para. 3 of the Professional Access Ordinance for Road Passenger Transport -PBZugV), not older than 3 months
- Clearance certificate from the tax office, the municipality, the social insurance institution and the employers' liability insurance association, not older than 3 months (from the company, the legal representative and the person appointed to manage the business / transport management)
- Certificate of good conduct for submission to the authorities in accordance with Section 30 (5) BZRG
- Extract from the central trade register in accordance with Section 150 (5) GewO (for companies)
- Extract from the driving aptitude register (FAER) for the licensee

General documents:

- Vehicle list
- Proof of liability insurance for buses and coaches including risk identification number (WKZ)
- Business registration
- A declaration of consent from the acquiring entrepreneur

Voraussetzungen

- The applicant is already in possession of a bus and coach license as an entrepreneur
- The safety and efficiency of the business is guaranteed.
- There are no facts indicating that the person taking over the business or the person appointed to manage the business is unreliable.
- The transferee as entrepreneur or the person appointed to manage the business is professionally qualified.
- The transferee and the entrepreneurs commissioned by the transferee to provide transportation services have their registered office or branch office as defined by commercial law in Germany.

	Legal entities under public law are deemed to meet the requirements.

Verfahrensablauf	<p>Proceed as follows to transfer the authorization for the commercial carriage of passengers by coach and bus:</p> <ul style="list-style-type: none"> • Submit a corresponding application to the licensing authority responsible for you and enclose all the necessary documents with the application. • The authority will process your application and carry out the necessary hearing procedures. • You will receive notification of the decision to transfer the bus and coach permit. • If applicable, the transferee will receive the certificate of approval.
Bearbeitungsdauer	The processing time may vary between the responsible approval authorities. The processing time may depend, among other things, on whether all documents relevant to the decision have been submitted or whether additional requests for documents are necessary. become necessary.
Frist	Deadlines only start to run when an application is ready for a decision. If your application is complete, a decision will be made within 3 months. The deadline can be extended by 3 months if necessary. if necessary.
