Teaser	If you wish to use a fishing vessel for eel fishing, you must register it with the competent authority.
Volltext	If you wish to use a fishing vessel for eel fishing, you must register the vessel with the higher fisheries authority. If your fishing vessel is registered in the European Community fishing fleet register or has an official mark, this must be stated when registering. For other fishing vessels (unregistered inland fishing vessels), the following information is required when registering: 1. Type 2. Length according to own measurement 3. Motorization with regard to engine type and 4. Official registration number of the vessel issued in accordance with other legislation, which must be displayed on the vessel Your registration number must be visible on the fishing vessel.
