Erforderliche Unterlagen	• Medical certificate of fitness (not older than three months), • Certificate of good conduct in accordance with § 30 (4) of the Federal Central Register Act (not older than three months), • Declaration of reliability
Voraussetzungen	• You have completed the prescribed training and passed the state examination, • You have not been guilty of any behavior that would make you unreliable to practice the profession, • You are not medically unfit to practise the profession, • You have the necessary knowledge of the German language to exercise the profession.
Kosten	Gebühr: 80€
Verfahrensablauf	• You submit your application to the competent authority using the online form and upload the required documents if necessary, • The permit is issued if the competent authority determines that the legal requirements have been met.
