Erforderliche Unterlagen	• Medical certificate of medical fitness (not older than three months), • Certificate of good conduct according to § 30 (4) Federal Central Register Act (not older than three months), • Assurance
Voraussetzungen	• You have completed the prescribed training and passed the state examination, • they are not guilty of conduct which results in unreliability for the exercise of the profession, • they are not unfit from a health point of view for the exercise of the profession, • You have the knowledge of the German language required for the exercise of your professional activity.
Kosten	Gebühr: 80€
Verfahrensablauf	• You submit your application to the competent authority via the online form and, if necessary, upload the required documents, • The permit is issued when the competent authority determines that the legal requirements are met.
