Erforderliche Unterlagen	• Medical certificate of health suitability (not older than three months), • Certificate of good conduct in accordance with § 30 (4) of the Federal Central Register Act (not older than three months), • Assurance
Voraussetzungen	• You have completed the prescribed training and passed the state examination, • You have not been guilty of conduct that results in unreliability in the exercise of the profession, • They are not unfit for the exercise of the profession from a health point of view, • You have the knowledge of the German language required to carry out your professional activity.

Verfahrensablauf	• You submit your application to the competent authority via the online form and, if necessary, upload the required documents. • The permit is issued when the competent authority determines that the legal requirements are met.
