Volltext	The legally prescribed requirements for the use of the professional title are examined. After successful examination, permission to use the professional title of hygiene inspector is granted.
Erforderliche Unterlagen	• Medical certificate of medical fitness (not older than three months), • certificate of practical training, • certificate of theoretical training, • Certificate of good conduct according to § 30 (4) Federal Central Register Act (not older than three months), • Certificate of passing the examination to become a disinfectant, • Assurance
Voraussetzungen	• You have completed the prescribed training and passed the state examination, • they are not guilty of conduct which results in unreliability for the exercise of the profession, • they are not unfit from a health point of view for the exercise of the profession, • You have the knowledge of the German language required for the exercise of your professional activity.
