Volltext	In the Soil Information System, data available for Hesse on the topics of soil information and precautionary soil protection at the Hessian State Agency for Nature Conservation, Environment and Geology (HLNUG) are made available to the public online via map viewer (Bodenviewer Hessen). These are, for example, soil properties, soil functions, soil erosion hazard or background values. In most cases, the data is also provided as OGC services and can be found in this form in the Geoportal Hessen. Further information and data can also be found on the HLNUG website. In addition to the provision of information via map viewer, there are also very individual or special requests, which are usually presented by experts in the field of soil protection.
