Volltext	<p>If you have already reported a borehole and have unintentionally encountered groundwater, you must report this to the competent authority immediately.</p> <p>The authority will inform you whether you may have to temporarily stop drilling.</p> <p>The responsibility of the water authorities depends on the location of the intended drilling points.</p>
