| | a reduction in income of more than 10%, an increase in the number of household members an increase of more than 10% in the rent or the cost of home ownership. |
| | These changes can, but do not have to, lead to an increase in housing benefit. |

| Verfahrensablauf | You will only receive a higher housing benefit if you apply for an increase. You must submit the application for an increase to the housing benefit authority responsible for you. Once the application has been processed, the housing benefit authority will issue a decision. |
| Bearbeitungsdauer | |
| Frist | Housing benefit is increased from the date of application. A retroactive increase in housing benefit is generally not possible. |

| Hinweise | If your financial situation or living circumstances have improved or changed, this may also lead to a reduction in housing benefit. You are therefore obliged to notify the housing benefit authority immediately of any changes that immediately to the housing benefit authority. |
